Terms of Use / Privacy Disclaimer

Thank you for visiting the Arts and Humanities Council of Southwest Louisiana's web site. Your privacy is very important to us. We respect and are committed to your privacy. This Privacy Policy lets you know what information is collected and how your personal information is processed and used.

Information Collected and Stored Automatically

When you visit the Arts and Humanities Council of Southwest Louisiana's web site, the Web server automatically collects certain data such as the Internet domain and IP address from which you accessed the site, the type of browser and operating system used to access our site, the date and time you accessed our site, and if you linked to our web site from another web site, the address of that site. This information does not result in the identification of your personal e-mail address or other personal information. We only use this information to help us make our site more useful to our visitors. Again, only aggregate information is collected, and your personal information is not identified.

Use of Cookies

We currently do not have "cookies" enabled. A "cookie" is a file placed on your hard drive by a web site that allows it to monitor your use of the site. On occasion, "cookies" are enabled to collect current data for updating our Web site and removing content that is not used or visited. This information is not shared with other organizations. Again, only aggregate information is collected, and your personal information is not identified.

Personally Identifiable Information

We may also request your e-mail address or mailing address for the purposes of conducting a survey or to provide additional services. Our policy is to collect no personal information about you such as your name, address, telephone number, or E-mail address when you visit our web site. Personal information is collected only if you provide that information to us voluntarily. Whenever we request the identity of a visitor, we will clearly indicate the purpose of the inquiry before the information is requested. We maintain a strict "No-Spam" policy. That means that we do not intend to sell, rent, or otherwise give your e-mail address to a third-party, without your consent. Certain forms require you to enter personal information such as your phone number, e-mail address or home address. This information is necessary if you are requesting information or services, so that we may return the information or confirm a service request. We do not share or reuse this information with other organizations.

If you choose to share personal information like sending an e-mail message, or filling out an electronic form with personal information, the information will only be used for the purposes you authorized. Some of this information may be saved for a designated period of time in order to comply with State of Louisiana laws and regulations for maintaining public record information. However, information will not be disclosed to third parties or other government agencies, unless required by state or federal law. If information is required by law to be disclosed about you, then every effort to notify you about the disclosure in advance will be taken.

Occasionally, the voluntary information we collect is used for internal review, to notify visitors

about updates to our Web site, and for the purposes of conducting a survey or to provide additional services. We may contact you or send you information about our updates or solicit feedback for services.

Please keep in mind that whenever you voluntarily disclose personal information online - for example through e-mail, discussion lists, or elsewhere - that information can be collected and used by others.
